1. Major irregularities noticed during inspections: -

- (A) At L.C/76/B/E/CDMR- SYJ in DDU division, it was found that a Trackman Grade- IV was working as Gateman without proper training & Knowledge for working as Gateman. Competency Certificate was also not issued to him to work as Gateman. This is a clear violation of provision of G&SR 16.01. Further, it was also seen that some competency certificates of Gatemen were issued without mentioning File No. & Sr. No. which was also emphasized earlier vide Safety Bulletin no. 03/2022.
- **(B)** At VPDA station in SEE division, description of MSDAC was not found written in SWR. It should be incorporated in SWR.
- (C) While doing ambush check of Brake Van of Train No. KS (Kheta Sarai) Goods at DDU station, it was found that on-duty Guard/Train Manager was keeping his Pressure Gauge in his Line Box as "Adapter" was defective. Availability of "Adapter" & "Pressure Gauge" in working condition must be ensured in all Goods Train.
- (D) At ARG station in SPJ division, during checking of joint TRD and Signal & Telecom Register, one deficiency was recorded i.e. 1 'U' bond missing has not been addressed even after 'three' more inspections have been done thereafter. Recorded deficiency should be addressed promptly.

Fire prevention practice review in rolling – stock maintenance.

Ensuring 100% provision of quick coupling arrangement/ provision of pressure guage in both in Coaching& Goods train.

Electrical

Counselling of crew regarding whistling before passing W/L or W boards.

Checks regarding Fire prevention/ safety item in Loco/ TRD/ Elect.(G) installations.

Engineering

Renewal/reconditioning of damaged/worn out Tongue rails.

Hot weather patrolling of track as per IRPWM guidelines.

S&T

Verification & correction of Yard Diagram & Circuit Diagram as per existing Yard (i) layout.

Review of unnecessary opening of Relay Room. (ii)

Security

Ambush check by RPF at L.C. Gates having high TVU. (i)

Commercial

Counseling of checking staff regarding duties during accident. (i)
